**TITLE:** Light Equipment Operator - Two Positions  
(Seasonal position with potential to transition to permanent employment)

**LOCATION:** Department of Public Works - Streets and Facilities Division

**SALARY:** \$18.28/hour

Join our team! The seasonal light equipment operator position is a great opportunity to serve the community and gain experience in a wide variety of public works construction projects. Seasonal positions are held for periods of up to 6 months, and those employees that exhibit a strong work ethic, willingness to learn, and good attitude will be considered for full time permanent positions within the Department of Public Works.

**DISTINGUISHING FEATURES OF THE CLASS:** The work involves responsibility for the operation of a variety of light motor equipment, machinery and tools on public works projects including the construction, maintenance and/or repair of municipal streets, bridges, parks and grounds, water distribution systems, wastewater collection systems and solid waste disposal. The incumbent also transports construction equipment and machinery to and from work sites. The incumbent also performs other activities connected with the work, including pre-shift inspections of trucks, routine lubrication and maintenance of equipment, and manual labor. The incumbent performs recurring manual duties related to the operation of the equipment and other duties as assigned when not operating equipment. The position is distinguished from that of Heavy Equipment Operator by the size, weight and complexity of the equipment operated. The work is performed under general supervision. Does related work as required.

**ADDITIONAL INFORMATION:** These positions will support the Streets & Facilities Division of the Department of Public Works in the construction and repair of roads, curbs, sidewalks, and drainage systems. The work can be physically demanding and is performed outdoors in all types of weather conditions, occasionally during off hours and weekends during emergencies.

**MINIMUM QUALIFICATIONS:** Possession of a valid New York State Class B Commercial Driver License (CDL) or a valid Commercial Driver License equivalent to a New York State Class B Commercial Driver License at the time of appointment and maintenance of said license for the duration of employment.
