## **TYPICAL WORK ACTIVITIES:**

Plans and schedules a program of preventive maintenance and repairs of buildings and equipment;

Assigns subordinate personnel to various maintenance and repair tasks and determines priority of work in collaboration with administrative superior;

Supervises the maintenance and repair of heating, plumbing, and other related electrical and mechanical equipment; Conducts periodic inspections of job sites;

Supervises and performs the repair and maintenance of buildings including painting, plumbing, heating, electrical, welding, roofing, carpentry and masonry;

Estimates cost of maintenance and repair projects;

Requisitions equipment and supplies according to a prescribed manner;

Creates and maintains appropriate records on maintenance operations;

Coordinates project work with subcontractors and other work crews;

Ensures that work crews are equipped with the appropriate tools, materials and equipment;

Trains employees regarding building and grounds maintenance and repair techniques;

Ensures the security of tools, equipment and materials;

Operates motor equipment, tools and machinery related to the work assigned;
