POSITION DESCRIPTION: This is a trainee position involving responsibility for learning the duties and routines in the operation and maintenance of a Type 1-A Water Treatment Plant. The incumbent in this position undergoes on-the-job training by assisting in the operation and maintenance of a Water Treatment Plant in order to become qualified as an operator. Does related work as required.

Employees serve as trainees until they obtain the required minimum grade certificates for a Type I-A plant. Once certified, the employee is eligible for promotion to Water Treatment Plant Operator without further examination.

MINIMUM QUALIFICATIONS:

- A. Possession of an Associate's Degree in Water/Wastewater Technology, Environmental Science, Engineering Technology, physical sciences, chemistry, biological sciences, life sciences or a closely related field with similar course curriculum; or
- B. Graduation from high school or possession of a high school equivalency diploma <u>and</u> successful completion of at least eighteen (18) college credit hours of math and/or science coursework; or
- C. Graduation from high school or possession of a high school equivalency diploma, which shall have included the successful completion of at least three years of high school mathematics <u>and</u> at least three years of high school science; or
- D. An equivalent combination of training and experience as defined by the limits of (A), (B) and (C) above.

<u>Note</u>: College degrees must have been awarded by, and college coursework completed at, a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education and/or U.S. Secretary of Education. If an applicant's degree was awarded by, or college coursework completed at, an educational institution outside the United States and its territories, the applicant must provide independent verification of equivalency.
